NCHICA and WEDI Release New Timeline for HIPAA Implementation Industry Must Start Work Now to Meet Regulatory Deadline

Research Triangle Park, NC and Reston, VA (February 11, 2009) - With HHS' recent publication of the final rule for X12 Version 5010 for HIPAA transactions, the NCHICA-WEDI timeline for HIPAA implementation has been modified to reflect the new required compliance date. Based on extensive analysis and industry feedback, the new timeline reflects the Jan 1, 2012 compliance date for 5010, and the expected January 2011 through December 2012 partner testing and implementation timeframe.

The critical path for implementation requires that vendors, health plans and providers all start their implementation work now. The expected analyses of business processes and IT systems, software development, testing and rollout is expected to take the full time allowed in the January 16th regulation published by HHS. Any delay in starting this work will jeopardize the ability of an entity to meet the compliance date.

Jim Schuping, the Executive Vice President & CEO of WEDI, stated, "There is a clear indication from CMS that they expect the industry to meet the compliance date, and there will be no contingency period. We have created this timeline as a guide and management tool for the industry to follow. WEDI will continue to monitor progress and provide guidance and assistance to enable the industry to meet the regulatory deadlines."

Holt Anderson, the Executive Director of NCHICA, added, "The NCHICA-WEDI timeline shows clearly the need to start now so that a successful move to the new HIPAA standards is accomplished by the industry. We must learn the lessons from prior implementations that any delay is a guarantee of failure."

NCHICA and WEDI will continue to work together on further timeline efforts. The Timeline Initiative team is developing an additional timeline for implementation of the new ICD-10 code sets, which have a compliance date of October 1, 2013.
